Declarations by the Parent

I declare that:

- 1. Terms and conditions:** I declare that I have read and understood the policies of the School as adopted and published by the School from time to time and agree to abide by these policies.
- 2. Disclosures:** I have already provided and will continue to provide details of any medical condition, health problem or allergy affecting my child; any learning difficulty, disability, or special educational need of my child, as well as any behavioural, emotional and / or social difficulty of my child (for example dyslexia, dyspraxia, attention deficit disorder, visual or hearing impairment or any condition requiring use of a wheelchair). I attach in confidence details of any relevant information received since my previous disclosure.
- 3. Medical matters:** I attach in confidence all relevant information about any medical condition, health problem, or allergy which affects my child and / or which may prevent my child from taking a full part in the School's academic and games or sports curriculum and outdoor activities.
- 4. Intervention:** I will cooperate with the school once it is recommended that my child needs professional assistance. I will refrain from disciplining my child at school.
- 5. Parental responsibility:**
 - I have parental responsibility (i.e. legal responsibility) for my child only.
 - My spouse and I both have parental responsibility for our child.
- 6. Culpability:** I accept that my child can be criminally charged if 12 years or older and I will pay for the damages caused by my child once he or she is culpable based on admission and/or a thorough investigation with evidence.
- 7. Meeting/Conference:** I accept that I will report to school once I am contacted to do so. If I am unable to report to school, I will send a relative to represent me. If nobody shows up for my child, I grant the school permission to represent my child.

I undertake to comply with all the rules and regulations of the School and acknowledge that it is my responsibility to be familiar with the school rules and policies.

I acknowledge that I am responsible for my Child, whether on the property of the School or not, after the notified finishing times of any school activity/event/function and that I will ensure that my Child obeys all school rules and policies.
